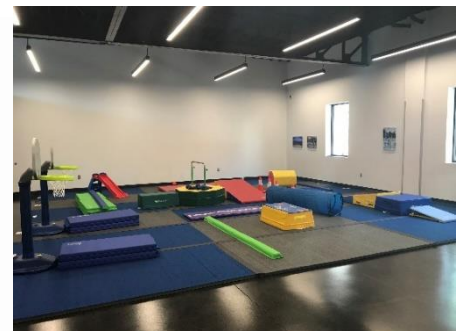

### **Pool Party Package – all ages**

Location: Fairway Pool – 6136 Mission Rd.

Available for groups ranging in size from 8-50 people. Party packages include:

- Pool Admission
- Two hours in a party room - You can choose your start time of 11:15, 1:30, 3:45, or 6:00.
- Choice of either pizza or hot dogs (1 pizza slice or hot dog per person)
- 1 medium soft drink for each person
- 1 bag of chips for each person
- 1 ice cream treat for each person

When you arrive for your party, let the pool staff know what time you would like your food to be ready.

Cost: \$10 per person

- Minimum of 8 people = \$80 due when you reserve your party time.
- The \$80.00 fee is non-refundable, but is transferable to another date if you need to reschedule.
- The balance due for additional guests is to be paid the business day before the scheduled party.

Note: The swimming pool will remain open to the public during all Pool Party Package parties.

### **Gymnastics Party Package – recommended for 7 years & under**

Location: Fairway City Hall – 5240 Belinder Rd

Available year-round for groups ranging in size from 10-25 children. Party packages include:

- 1 hour in the gymnastics room
- 30 minutes in the party room
- 1 slice of pizza per person
- 1 drink for each person
- 1 bag of chips for each person
- 1 ice cream treat for each person

Cost: \$15 per person

- Minimum of 10 people = \$150 due when you reserve your party time.
- The \$150.00 fee is non-refundable, but is transferable to another date if you need to reschedule.
- The balance due for additional guests is to be paid the business day before the scheduled party.

Available Add-Ons

- Additional 30 minutes in the gymnastics room (\$25)

### **Nerf Party Package – recommended for 6 years & older**

Location: Fairway City Hall – 5240 Belinder Rd

Available year-round for groups ranging in size from 10-25 people. Party packages include:

- 1 hour in the nerf room
- 30 minutes in the party room
- 1 slice of pizza per person
- 1 drink for each person
- 1 bag of chips for each person
- 1 ice cream treat for each person
- 1 pair of safety glasses for each participant

Cost: \$15 per person

- Minimum of 10 people = \$150 due when you reserve your party time.
- The \$150.00 fee is non-refundable, but transferable to a date in the calendar year if you need to reschedule.
- The balance due for additional guests is to be paid the business day before the scheduled party.

Available Add-Ons

- Additional 30 minutes in the nerf room (\$25)
- Nerf gun & dart rental for each participant (\$5 per participant)

### **Terms and Agreements**

1. Party Package rentals are subject to facility availability and must be requested by persons at least 18 years of age.
  2. Pool Party Package applications are for the Pool House only. The remainder of the pool will remain open to the public.
  3. The reserving party may not charge admission.
  4. Party Package applications must be submitted with full payment a minimum of one week in advance of the rental date to the Parks & Recreation Department at City Hall, 5240 Belinder Road. Swimming Pool staff may not schedule rentals at the swimming pool.
  5. Possession and consumption of alcohol at Party Packages is prohibited.
  6. Children and youth groups must provide one adult for every 10 children.
  7. Party Packages include tables and chairs for the requested amount of party participants.
  8. Party Package setup and cleanup will be completed by staff party attendant.
  9. Party Package fees are non-refundable. Party Packages may be re-scheduled during the current calendar year if cancelled at least 24 hours prior to the start time (subject to facility availability).
  10. Any group wishing to bring in a third-party (such as clowns, disk jockey's, caterer's etc.) to facility must list the vendor(s) on this form at the time the application is submitted.
  11. The City will request proof of liability insurance from the rental applicant as well as any third-party vendors. The City shall determine the level of coverage necessary, which may include requiring the rental applicant or the third-party vendor to list the City of Fairway as "additional insured" and a "Certificate Holder" on the holder's policy.
  12. The City reserves the right to deny, cancel, postpone or terminate any portion of a Party Package rental for safety reasons related to weather, unsafe actions of the renter or if doing so is deemed in the best interest of the City.
